Concept Note

IPR provide certain exclusive rights to the inventors or creators of a property,

in order to enable them to reap commercial benefits from their creative efforts or reputation. Intellectual property (IP) protection supports the development of knowledge-based industries, stimulates international trade and encourages investment and technology transfer. In recent years India has made robust progress not only in implementing its obligations under the WTO Agreement on TRIPs Rights, but also in developing its own IP regime which endeavours to balance the trade-off between monopoly rights and free access to knowledge.

Through discussions of both practice and theory, as well as interactive exercises, participants will gain practical insights into the important issues like evolution of Indian laws for better protection of IP domestically, the continuous development of IP case laws in India especially cases of pharmaceutical cases, necessary legislation to bring India's IP regime up to international standard and recent efforts made to improve enforcement of IP legislation in India.

The focus of the Workshop is on the nature of the changes, the challenges present for national and international IPR systems, and their implications.
