Tender must be submitted on or before 24/03/2020 at 03 P.M at the Office of the Registrar, Aliah University, IIA/27, New Town, Kolkata- 700160, West Bengal, India by Speed-post/registered Post/by hand.

Incomplete applications or applications received after the last date of submission will not be considered. The sealed envelope must be with super scribing the Name, e-mail, Contact No. of Tenderer, NIT Reference Number and Purpose of NIT. Interested bidders are requested to provide their Quotes following the format in Annexure- II in their official letter heads along with signed Compliance Statement and Price Bid (Annexure- III). ANNEXURE I: GENERAL TERMS & CONDITIONS

• Service To Be Done at AUAT Section, Aliah University New Town Campus, IIA/27, New Town, Kolkata – 700 160, West Bengal within 21 working days of issuing work order.

• Eligibility:

Technically sound agencies having adequate infrastructure and experience of handling work of similar nature i.e. online application processing and entrance examination process of various Universities/ Colleges/ Government Bodies involving multiple subjects and online declaration of results are eligible for this tender.

The bidder must fulfill the following criteria.

- 1. The bidder should have a minimum turnover of Rs. 60 Lakhs in each or on average during the last 3 financial years viz. 2016-17, 17-18, 18-19.
- 2. The bidder must have successfully handled at least 5 confidential work order in University/ Govt./ Govt. undertaking in last three year and atleast one assignment of managing online applications of 100000.
- 3. The bidder should furnish work order/ job completion certificate in favour of their claims for successful handling of such job(s).
- 4. The bidder should be technically sound with adequate infrastructure and should have disaster management capabilities.
 - 5. The bidder should have audited balance sheet for last three years viz. 2016-17, 17-18, 18-19.
- 6. The bidder must have a valid Trade License, PAN, GST/ VAT/ Sales Tax/Service Tax registration number.
- 7. The bidder should have a registered office in West Bengal with proper infrastructure, facilities, confidential data centre and experienced manpower. Also, the bidder must have an operational set up in Kolkata to execute the entire job.
- 8. Mere fulfillment of minimum eligibility criterion does not guarantee qualification of a bidder in technical evaluation.
 - 9. Any of the eligibility conditions can be relaxed at the discretion of Aliah University.

Scope of Work:

- 1. Development of AUAT 2020 Portal and integration with Aliah University Website:
- 1.1. Hosting of application management system and associated database on a fast, fault tolerant, fail over, reliable and globally accessible server connected through high bandwidth. Link is to be provided on Aliah University website.
 - 1.2. Domain name registration.
 - 1.3. Mirroring of database to a specified Aliah University server.
 - 1.4. Hosting Information Bulletin(s) on the portal in pdf format.

2. Online Submission of Application Forms:

- 2.1. Design online form with fields to be specified by Aliah University.
- 2.2. Registration by the candidate through valid mobile number and email. Application window will remain active at different time periods for different courses/programmes as specified in the Information Bulletin(s).
- 2.3. Confirmation of registration number and password sent through SMS and email to candidates. Reset of password/recovery of registration number through SMS and email.
- 2.4. Help pop-ups and required prescribed validations for each field including eligibility conditions/ date of test for various courses. Eligibility conditions include percentage of marks in qualifying examination and age limit.
- 2.5. Uploading of data, scanned documents (Specified certificates to check eligibility), colour photo and signature by the candidate. Acceptance of images only in proper size and resolution is to be ensured. For applicants with qualifying examination result awaited to be allowed to upload that particular data and scanned certificate/ grade card at a later duration as specified by Aliah University.
 - 2.6. Integration with designated payment gateways as specified by Aliah University.
 - 2.7. Scope for different application fee for different category of applicants to be available.

- 2.8. Display of final shape of form (with entries *I* other static essentials prescribed by Aliah University) to candidate before final confirmation of entries and submission of forms. Features to accept forms complete in all respects and after successful payment are to be provided.
- 2.9. Print/ download facility (browser independent) of complete form in pdf format with auto generated form number to be available to the candidate only after successful payment and a copy to be sent to the email address simultaneously.
- 2.10.To provide telephone and email help desk for answering queries of applicants regarding online registration process.

3. Processing of Database:

- 3.1. Daily course wise list of applications who have applied successfully is to be provided.
- 3.2. Regular display of Application status to candidates through login facility.
- 3.3. Generation of roll number as per scheme provided by Aliah University.
- 3.4. Test Centre management module having required flexibility as specified by Aliah University.

4. Admit Card and Verification Roll Generation:

- 4.1. Test centre allocation to the candidates as per instructions of Aliah University.
- 4.2. Preparation of admit card with photo and signature in grey scale as per prescribed format.
- 4.3. Availability of Admit cards for download.
- 4.4. Dispatch of admit card to the candidates email address along with SMS alert.

5. Result Processing and Rank Card Generation:

- 5.1. Based on percentage of marks in qualifying examination, results of admission test and absentee list provided by Aliah University, category wise rank list is to be prepared for each of the courses.
- 5.2. No rank will be given to a candidate with qualifying examination result awaited who fails to secure minimum percentage of marks in the qualifying examination.
- 5.3. Results will be published on the portal and individual rank card for each of the successful applicants appeared in different admission tests should be available for download during specified period.

6. Registration for e-Counselling:

- 6.1. Candidates having a rank, in any of the tests for which he/ she appeared, will be allowed to register for e-Counselling.
- 6.2. Candidates registered for e-Counselling can fill the choice from the list of available programs based on the test papers they have qualified during a period specified by Aliah University.

7. Seat Allotment and Online Admission:

- 7.1. Seat allotment will be done on the basis of category wise available seats in a programme/ course (provided by Aliah University), choice preference given by the candidates, his category and rank in the entrance examination. Allotment lists are to be published in the portal.
- 7.2. A candidate being allotted a seat would be able to pay online the requisite admission fee and an intimation regarding verification of documents, place and date of verification has to be generated and be available for download.
- 7.3. The allotment and admission fee payment process can be repeated multiple times, minimum three rounds. An admin interface will have to be provided to Aliah University for recording the candidates accepting the offered seats after each round.
- 7.4. Candidates not accepting the offered seats, within the stipulated time, will not be considered for further rounds.
- 7.5. Candidates accepting an offered seat by paying the admission fee will be allowed to opt to participate in further rounds of allotment for a seat in a programme with his/ her higher choices until he/ she has not been able to secure a seat of his/ her first choice.
- 7.5 Candidates should get a provisional Identity card after successful admission to their respective department.
- **8. Backups:** Retention and provision of database to Aliah University (in MS Access/ MS Excel format) to be provided for generating different types of statistical reports and graphs for future use.

• <u>Partial quotations are not allowed for this tender i.e. bidder should quote all item.</u> For overall item lowest bidder (L1) will be selected.

- All disputes are subject to exclusive jurisdiction of competent Court and Forum in Kolkata, India only.
- Any dispute arising out of this contract shall be referred to the Registrar, Aliah University, and if either of the parties hereto is dissatisfied with the decision, the dispute shall be referred to the decision of an Arbitrator, who should be acceptable to both the parties, to be appointed by the Vice-Chancellor of the University. The decision of such Arbitrator shall be final and binding on both the parties.
- Payment Condition:-The prices shall be inclusive of all taxes & levies including GST and other statutory duties as applicable. Rate of taxes should be indicated separately in the Price Bid. Contract Price specified in Price Bid should be based on the taxes & duties and charges prevailing at the date one day prior to the last date of Bid submission. Statutory deduction, wherever applicable, shall be made from invoice as per government rules. Necessary certificate will be issued for such deductions. Bidder submitting a bid shall produce valid statutory documents / certificates with respect to GST, Income Tax, ROC, Prof. Tax, Trade Licence, etc. All such documents / certificates shall remain valid on the last date of tender submission. GST component of the invoice of the bidder may be kept on hold in case there is any mismatch / irregularity in GST return filling on the part of the bidder.100% payment will be released after receiving of items in good order and condition and installation (if any) duly certified by the concern authority and immediately on receipt of fund from the Govt. Department (within 60 days from the submission of bills). Successful vendor should arrange to submit a performance security deposit in form of Performance Bank Guarantee to the tune of 10% amount of the total purchase value at the time of submitting the bill. This performance security deposit should be issued from any Nationalized Bank and validity of the same will be till 1 year or warranty period +60 days whichever is higher from the date of delivery of the material.
