- 1. **Service** must be start within 14 days of issuing work order and must be delivered at Aliah University, New Town Campus and Park Circus Campus
- 2. The Service is for maintenance and includes repair and replacement of the following parts free of charge <u>example gracia :-</u> a) All kinds of filters b) Pre-filter candle c) Carbon block d) RO Membrane e) Flow Restrictor Tube f) Post Carbon Filter g) RO Pump h) Adapter i) All Valves j) PCB (circuit) k) TDS Controller l) SV (Stopper) m) Motors n) Worn out parts etc.
- **3.** The Quotationer should bear all the transportation & insurance **risk** till the ondoor delivery point. Selected bidder shall take all possible care for Govt. Property & of any damages due to negligence of his workers; the bidder/Agency shall be responsible for all such damages & repair the same at his own cost.
- **4. The rates** so quoted must be inclusive of GST, Central Excise, customs Duty if any, packing freight to destination, Insurances and levies and necessary installation and fixing at designated places at Aliah University and all charges i.e. cost of Equipment and other incidental charges for supplying at destination level and delivery charges up to the point of delivery at proper destination level and as per instruction in the work/ supply order.
